Background

The 2nd International Seminar “New approaches for maintaining work ability of long-term sick-listed patients” is part of an international cooperative research project with two core partners, National Advisory Unit on Occupational Rehabilitation in Rauland, Norway, and the FOM Hochschule. The 1st seminar in this international seminar series took place in Frankfurt am Main, organised by the KCI and the National Advisory Unit on Occupational Rehabilitation in November 2015. This year three new partners got involved and strengthened the research network, the KU Eichstätt and the Cardinal Stefan Wyszyński University Warsaw as project partners and the FOM “Institut für Gesundheit & Soziales” (ifgs) in Munich as seminar organizer as well as project partner. Therefore, one aim of the initial KCI research plan to establish and strengthen a small research network in Europe on occupational rehabilitation and public health has been achieved. The next aim will be to put together a joint grant application and publish research at an international level.

Aims of the 2nd International Seminar:

1. Knowledge transfer and exchange based on the seminar contributions
2. Brain storming session with follow-up workshop to find-out and evaluate funding opportunities at the European level
3. Plan to submit at least one research funding application at the European level
4. Publication of the seminar contributions and additional compatible themes till the end of 2017.
